#### What Applicants Should Expect:


- Applicants will receive an email from <u>noreply@umich.edu</u> with subject: Michigan Medicine Onboarding - Enterprise Health Portal Activation

- If you do not receive this portal activation email with 1-2 days of receiving your contingent offer letter:
  - Check your junk/spam folders for the email.
  - Contact OHS at 734-764-8021, state that you are an applicant and did not receive the Enterprise Health Portal Activation email.


